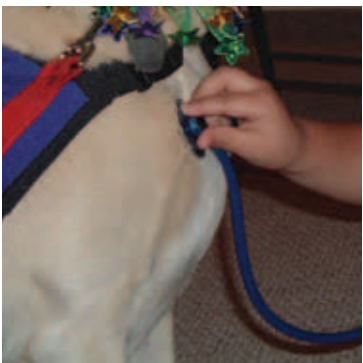

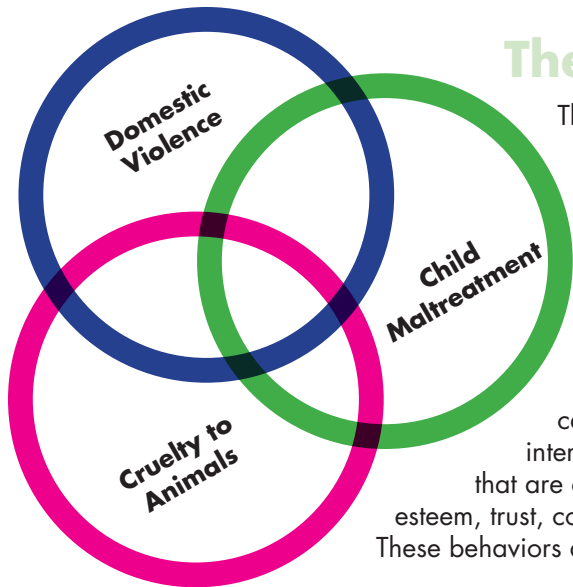
Celebrating 10 years of service, we have over 150 Pet Therapy Teams healing over 13,000 children in crisis each year – but the need remains great. Each day another shelter, group home, or after school program for at-risk children calls wanting a therapy dog to visit their kids – working the magic that only the unconditional love of a therapy dog can.

Statistics show that children who are victims of violence repeat the very cycle of violence they were victims of unless some unique intervention method occurs. This is what Gabriel's Angels does. By teaching children empathy, compassion and trust we **are** preventing future abuse to humans, as well as our animal friends.

In January of 1999, I brought home a puppy and named him Gabriel. Gabriel's Angels Founding Dog passed away in May 2010 after 10 years of service. He ignited a revolution of therapy dogs healing children in crisis. *All of you are Gabriel's Angels... Let the legacy live on!*

The "Link"

The term "Link" as coined by the American Humane Society, defines the substantiated correlation between child abuse, animal cruelty and other crimes of violence against humans. It is undeniable that animal abuse is often one of the early signs of families in crisis and is highly predictive in identifying children at risk for abuse and becoming potential abusers. This type of violence is insidious, cyclical and is passed on from one generation to the next without some form of intervention.

Current research shows that children who are abused are more likely to become abusive adults. However, the strongest predictors of subsequent violence and abuse can be changed. Gabriel's Angels Pet Therapy Program addresses the root cause of this social problem by treating the symptoms and cause of the problem and intervening in this perpetuating cycle. We work on improving healthy core behaviors that are crucial to normal childhood development, focusing on improving empathy, self-esteem, trust, compassion, respect, and encouraging nurturing behavior in a safe environment. These behaviors are also proven to interrupt the cycle of violence.

To be the premiere provider of innovative children's pet therapy programs through out the country.

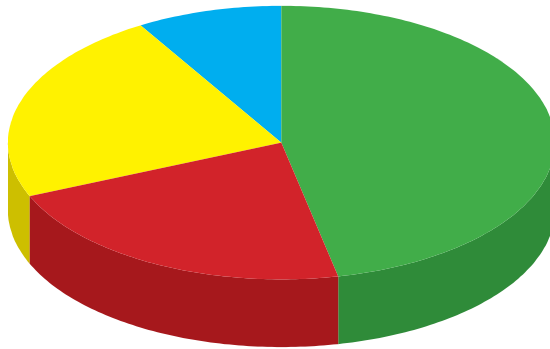
Mission

The bond between a therapy dog and a child is strong enough to break the cycle of violence.

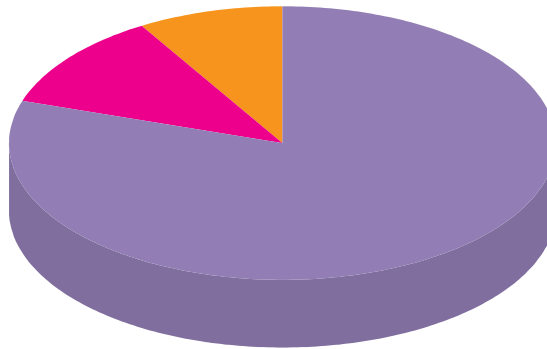

History

Gabriel's Angels is named after our founding therapy dog, Gabriel, and our 'angels'...the children we serve, our donors, supporters and volunteers.

The organization began in 1999 when Pam Gaber, a volunteer at the Crisis Nursery in Phoenix, took her Weimaraner puppy, Gabriel, to the holiday party dressed as Rudolph the Red-Nosed Reindeer. Something magical happened at that event, as children's behaviors changed from shyness and anger to kindness and compassion. Gabriel reached the children in a way that amazed everyone.

Pam and Gabriel became certified through Delta Society, and soon a group of handlers and pets came together to form a club to deliver pet therapy. Results with these first children exceeded expectations, as on-site caregivers and social workers quickly confirmed that the children were more empathetic and nurturing to one another.

In response to overwhelming community support and encouragement, Gabriel's Angels was incorporated as a nonprofit organization in the State of Arizona on May 12, 2000. On January 24, 2001, we were granted our 501(c)(3) status by the Internal Revenue Service retroactive to date of incorporation.

In 2009, Gabriel's Angels has grown to 150 volunteer Pet Therapy Teams serving over 13,000 children in crisis nurseries, domestic violence and homeless shelters, group homes, residential treatment centers and self-contained classrooms in Phoenix and Southern Arizona. Each dog must undergo a certification process and each volunteer must pass the standard security screening required by state law. There is no cost to the participating agency to receive pet therapy visits for their children.

Gabriel's Angels future vision is to add 170 Pet Therapy Teams reaching an additional 10,000 children annually in Arizona.

During 2010, Gabriel's Angels is celebrating our 10th Anniversary while coping with the passing of our beloved Gabriel. During his 11 years he left an inspiring legacy of unconditional love and promise for thousands of abused, neglected and at-risk children. Because of him hundreds of dogs, along with their owners, have been inspired to give and truly make a difference. Gabriel's legacy continues through his many 'angels'...the children we serve, our donors, supporters and volunteers.
